 - Insurance that actually covers the activity conducted
Note: Insurance will not cover physical contact (double check Insurance framework or guidelines) and definitions as Risk management and Duty of care will have a great bearing over Insurance Claims as **Common Law** will over-ride Insurance paperwork claims . Common Law is the Over-riding factor and Insurance framework must be written in harmony with and subservient to the Australian Common LAW
- **Risk management and duty of care :**
awareness of Risk management and duty of care during classes and in the act of conducting and teaching classes is covered by our brief on the subject written by lawyer Robert Phillips (6 th Dan and co-director of UMASD Pty Ltd) basically any form of (Flesh to Flesh contact and negligent practices) have a **high level of Risk** and this is one prime reason that Healy's Health and United Martial Arts Academy focuses on Skills and Drills in most class activities thus mitigating Risk factors.

- **Taxation obligations and laundering of Money (in excess of \$10,000 AUD that falls under the Anti-Money Laundering and Counter Terrorism Financing Act)**

Unfortunately , Even though many Martial arts organizations claim to have INTEGRITY , most operate Illegally, laundering undeclared CASH monies in nothing more then a Ponzi Scheme:

where cash funds are laundered to the 'Master' at the top of the pyramid. Also Visiting 'Masters' from overseas destinations arrive in Australia on Visitors Visa's for the purpose of conducting Grading and seminars in Australia receiving considerable amounts of **UNDECLAIED CASH MONEY** and in the meantime 'preach' Honesty, Integrity etc in fact nothing could be further from the TRUTH .

These activities are nothing more than **CRIMINAL, TAX AVOIDENCE Ponzi schemes** and if detected by Audit from the ATO (Australia Tax Department) or the Department of Immigration these activities may carry criminal charges and if convicted hefty fines or possible jail sentences.

DO YOU WANT TO BE EXPOSED TO THIS KIND OF CRIMINAL ACTIVITY? and RISK?

So much for martial arts Integrity and Honesty in many cases.

- **Also laundering Cash Money in excess of \$10,000 falls under the Anti-Money Laundering and Counter Terrorism Financing Act.** So the little 'unmarked envelopes' of cash money slipped into the back pocket of 'The Master' (either visiting from Overseas on a Visitors Visa) or Domestically within Australia **IS A CRIMINAL ACTIVITY PERIOD.**

If not a resident with a Tax File Number (TFN) and/or Australian Business Number (ABN) then the supplier must withhold tax at the full marginal tax rate.

c)NO LAUNDERING of Cash Monies in excess of \$10,000 AUD which falls under the **Anti-Money Laundering and Counter Terrorism Financing Act** which is a CRIMINAL ACTIVITY .
